C.J. DAVIDSON COLLEGE SCHOLARSHIP

TEXAS ASSOCIATION FAMILY, CAREER AND COMMUNITY LEADERS OF AMERICA

Family, Career and Community Leaders of America awards one (1) scholarships to outstanding members in Texas majoring in Family and Consumer Science Education in a Texas college or university. The scholarship is \$2,250 per semester (\$13,500) for up to six (6) semesters if the recipient continues to be qualified under the governing rules of the scholarship (see Page 3).

<u>APPLICATION PROCEDURE:</u> Applications should be completed in full and submitted on-line to the Association, which will carry out the evaluation process and determination of the recipient of the scholarship(s) awarded.

SUBMITTED BY FEBRUARY 1, 2024: All applications must be submitted on-line with all required documentation and signatures by 11:59 pm CST on February 1, 2024. No exceptions will be made.

APPLICANT ELIGIBILITY: To be eligible to apply for this scholarship, an applicant must meet the following criteria:

- Citizenship/Residency: The applicant must be a citizen of the United States and/or be born in the United States and a resident of the State of Texas. If place of birth of applicant as indicated on application and/or transcript is other than the United States, appropriate proof of citizenship must be furnished.
- **Graduation:** The applicant must be a Texas high school graduate and in good academic standing an accredited college or university within the confines of the State of Texas. This is to be verified by submitting an official transcript or by an accompanying certification from an appropriate school official from the applicants high school.
- Marital Status: The applicant must not be married
- College Entrance Examination: No application will be accepted without test scores. The applicant must have
 taken either the SAT or ACT college entrance examination and furnish proof. Proof of the score may be a part of
 the official transcript or a copy of the official test results should be attached to the application. The information
 should reflect the date the test was taken. The highest test score will be used for evaluation but scores from
 different test dates will not be combined.
- FCCLA Membership Requirement: The applicant must be a former member, in good standing, of an affiliated chapter of the Texas Association, Family, Career and Community Leaders of America for at least one year and be eligible to compete for an FCCLA college scholarship to be used beginning with the fall semester of the year in which the scholarship is awarded.
- Collegiate Enrollment: The applicant must be currently enrolled in an accredited college or university within the confines of the State of Texas and MAJOR IN ANY AREA OF FAMILY AND CONSUMER SCIENCES. Applications will not be accepted from students who are not currently rerolled students. This is to be verified by submitting an official transcript or by an accompanying certification from an appropriate school official. Applicant's scholastic average is to be reported on the application; average must be expressed as a numerical percentage or as a grade point ratio with the scale indicated. An explanation of the grade scale must accompany the application or be part of the official transcript.
- Activities: Leadership potential and character of the applicant should be demonstrated through an applicant's
 responses to the categories of the application detailing school, extracurricular and community activities and
 achievements. Personal references should provide additional information as well.

- Narrative: Each applicant must include a typed narrative of approximately 200 words explaining "How FCCLA and your Family and Consumer Sciences coursework prepared you for the future". Applicant's name, home address with county, chapter name, and chapter ID, must be typed as a heading to the narrative in the upper right hand corner of Page 1.
- Additional Essay: Include an additional essay of approximately 200 words on the topic of "The Importance of Family and Consumer Sciences Education."
- Letters of Recommendation: Each applicant must submit three (3) letters of recommendation from persons who are non-family members (two of whom should be former or current instructors). Letters should be typed and should include the name, address and daytime phone number of the person making the recommendation, as well as an indication of the person's relationship to the applicant (teacher, minister, employer, relative, etc.) These letters must be submitted with the application. References should indicate knowledge of applicant's character, determination to pursue a college education and any other factors, which will assist evaluation. No more than three (3) letters may be submitted per applicant; no letter should exceed two pages in length.
- **Documentation:** Each application must be accompanied by an official transcript showing academic average and grading scale through four years of high school, class size and official ranking of applicant; citizenship status if place of birth is other than the United States; proof of either SAT or ACT scores; certification of FCCLA membership; narrative; and references. All documents must be uploaded individually on-line in a PDF format.

EVALUATION PROCEDURE: For the purposes of evaluation of applicants, a selection committee independent FCCLA will review all properly completed applications. Incomplete applications will not be considered. Applicants are evaluated on the basis of academics, leadership/citizenship and financial need.

RECEIVING THE SCHOLARSHIP: To be awarded the regional special scholarship (Blue Bell) all winners are required to attend the Texas FCCLA State Leadership Conference, March 30th - April 2nd, 2023 in Dallas, TX. In the event a Blue Bell scholarship recipient does not attend the awards ceremony, the said scholarship will be awarded to an alternative winner.

PAYMENT OF STIPEND: It is the responsibility of the scholarship recipient to notify the FCCLA office of the address of the Financial Aid Office at the college or university to be attended. This notice must be given a minimum of thirty (30) days prior to the beginning of each semester. Payment of the scholarship will be made directly to the Financial Aid Office at the rate of \$2,250 in which the recipient is enrolled for 15 or more semester hours and is in good standing academically per the governing rules of the scholarship (see Page 3).

GOVERNING RULES

- 1. Each semester recipient must request for the chair of the Family and Consumer Sciences Department to confirm that the recipient is majoring in family and consumer sciences. A letter verifying this fact shall be sent to: Family, Career and Community Leaders of America, 1107 W. 45th Street, Austin, Texas 78756 or fccla@texasfccla.org.
- 2. Recipient shall furnish an OFFICAL transcript of grades at the completion of each semester to: *lcarroll@texasfccla.org* or *fccla@texasfccla.org*.
- 3. Upon receipt of verification of the scholarship recipient's acceptance by a college or university, FCCLA shall disburse money to the Registrar or Financial Officer of the college or university.
- 4. This money shall be used to defray cost of tuition, fees, books, and room and board.
- 5. Upon receiving written notice of the applicant's acceptance for enrollment the second semester, the FCCLA office shall again dispersed the money to the Registrar or Financial Officer of the college or university. This procedure will be repeated for the length of the scholarship award, as long as the recipient continues to meet the requirements.
- 6. The recipients shall be expected to enroll and maintain a course load of 15 hours per semester. Any deviation from this shall make recipient ineligible, unless the scholarship committee and the State Advisor have granted approval prior to the start of the semester in question.
- 7. The recipient shall be ineligible upon drop of grade average below C+ (2.5 on a 4.0 system), change of major from Family and Consumer Sciences or marriage.
- 8. Should the recipient forfeit the scholarship, the scholarship committee shall name an alternative recipient who would then receive the scholarship under the regulations herein stated.
- 9. Recipients shall remain in contact with the FCCLA office through the duration of the scholarship award. Failure to do so will constitute a willing forfeit on behalf of the recipient of the remainder of any monies allocated to student.
